

ORDINANCE NO. 90-6

AN ORDINANCE OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT  
AMENDING CHAPTER 14 OF THE DISTRICT CODE RELATING TO  
WATER SERVICE  
AMENDING CHAPTER 15 OF THE SEWER CODE RELATING TO  
SEWER SERVICE

BE IT ORDAINED by the Board of Directors of the Rancho Murieta Community Services District, Rancho Murieta, Sacramento County California, as follows:

SECTION ONE:

Section 9.03 of Chapter 14 relating to water service, Persons Billed, is modified as follows:

- (a) The District shall bill the property owner directly for all water services provided the owner's premises.
- (b) The property owner shall be liable for payment of all District charges.

Section 7.07 of Chapter 15 relating to sewer service, Persons Billed, is modified as follows:

- (a) The District shall bill the property owner directly for all sewer services provided to the owner's premises.
- (b) The property owner shall be liable for payment of all District charges.

SECTION TWO:

To the extent the terms and conditions of this Ordinance may be inconsistent or in conflict with the terms and provisions of any prior District ordinances, resolutions, rules, or regulations, the terms of this Ordinance shall prevail with respect to the terms and provisions thereof, and such inconsistent or conflicting terms and provisions of prior ordinances, resolutions, rules, and regulations are hereby repealed.

SECTION THREE:

This Ordinance shall be in full force and effect sixty (60) days after adoption and shall be published not less than once in a newspaper of general circulation published in the District within ten (10) days after adoption.

SECTION FOUR:

The establishment, modification, structuring, restructuring and approval of the fees, rates, tolls, or other charges as set forth herein are for the purposes of continuing to meet the District's costs for operation and maintenance, supplies and equipment, financial reserves, and capital replacement needs, and are necessary to maintain service within the District's existing service area.
