

WATER SHUTOFFS TO RESUME IN EARLY 2022

The Governor's shutoff moratorium ended December 31, 2021. What does this mean to our residents? As of January 1, 2022, the District now has the capability to enforce water lock-offs due to non-payment. The District's goal is bring all of our outstanding accounts current to prevent potential water lock-offs. We understand there may be extenuating circumstances and we want to work with you. If your account is delinquent and you are unable to bring your account current immediately, we ask that you contact us as soon as possible to complete a payment installment agreement. GM CORNER UPDATES TO STATE'S SOLID WASTE LEGISLATION IN 2022

As part of our continued partnership with the Community of Rancho Murieta, Cal-Waste wants to share some information regarding new legislation that is coming into effect next year. This information was presented to the Rancho Murieta Community Services District Board of Directors at their October 2021 meeting. This is the third piece of a multi-part series to share information about the State's solid waste mandates and how they will affect Rancho Murieta and Cal-Waste.

The new legislation focused on diverting organics from landfills (SB1383) will come with some minor lifestyle changes in how waste is sorted at residences, but the truth is organics recycling is nothing new. In fact, "Archaeological evidence shows that the ancient Scots, about 5000 BC, planted crops in heaps of rotting manure," according to the Compost Foundation. For many folks, they may already be composting at home to sustain their gardens and flower beds.

Sourcing food waste (mixed with other household waste) is deeply imbedded in Cal-Waste's roots from when the company was founded in 1927 by Colombo Vaccarezza with the business model of collecting food waste, along with other municipal waste to be used as feed for hog farms. The mindset of collecting someone's waste as a viable resource to be used somewhere else continues to ring true for the waste industry today. In the past 15 years, food waste has been recovered from food processors and used in anaerobic digesters to create energy, and it has also been used in composting facilities to make compost and soil amendments.


As the effects of state mandates related to organics recycling approaches, you can be confident that an organic waste recycling program will benefit your community by creating new resources for our local communities and local economy by recovering a waste stream that would otherwise go to a landfill.

This also helps achieve the state's goal of limiting greenhouse gas emissions that are emitted today from landfills.

KEEP YOUR WASTEWATER/SEWER LINES OPEN

Although we flush human waste down the toilet it does not mean sewers are waste disposal units. Sewers are not designed to cope with modern *disposable* products, and as a result these items can cause blockages. The drains connecting your home to the main sewer are only big enough to carry water, toilet paper, and human waste. They are often no wider than four inches. Around 75 percent of blockages involve *disposable* items. Avoid sewer line blockages which can be a drain Only toilet paper down the toilet on your finances due to expensive plumbing repairs.



Remember to bag it and put in the garbage ... don't flush it!

DEVELOPMENT UPDATE

Retreats – Work has continued with storm and sewer lines being installed along what will become Robbia Way (off of De La Cruz). The site was issued a Notice of Violation on December 29, 2021 by the District for failure of erosion control and sediment control BMP's to prevent sediment from leaving the site. The developer responded swiftly and shut down the north portion of the project for the winter and had increased erosion and sediment BMP's including hydroseeding the exposed soil on site.

Riverview - Water and sewer line installation have been completed for Phase 1a along Reynosa Drive. Drainage infrastructure has been installed from Reynosa Drive to Bird loop.

COMMUNITY FAQ's

RESERVOIR LEVELS

We understand that the Community is very interested in the levels of the Reservoirs, so we plan to update you monthly on those levels through the winter and spring. As of January 19, 2022 we are pumping from the river and continue to pump daily (if possible) to fill the Reservoirs. According to the data:

- Calero is 78% full
- Chesbro is 90% full
- Clementia is 100% full

The District can fill the Reservoirs from the Cosumnes River from November 1st until May 31st. The flow at Michigan Bar must be 70 cubic feet per second, and the water must be free from debris. You can monitor the flow at: https://waterdata.usgs.gov/ca/nwis/uv/?site_no=11335000
