RESOLUTION 90-12

RESOLUTION CALLING GENERAL DISTRICT ELECTION

WHEREAS, an election will be held within the Rancho Murieta Community Services District on November 6, 1990, for the purpose of electing three (3) members to the District Board of Directors; and

WHEREAS, a statewide general election will be held within the County of Sacramento on the same day; and

WHEREAS, Elections Code Section 23302 requires the District to file with the Board of Supervisors, and a copy with the Registrar of Voters, a resolution requesting consolidation with a statewide election.


THEREFORE, BE IT RESOLVED, that the Rancho Murieta Community Services District requests the Board of Supervisors of Sacramento County to consolidate the regularly scheduled General District Election with the statewide election to be held on November 6, 1990; and

THEREFORE, BE IT RESOLVED, that the candidate is to pay for the publication of the candidate's statement, pursuant to Election Code Section 10012. The limitation on the number of words that a candidate may use in his/her candidate's statement is 200 words; and

BE IT FURTHER RESOLVED, that the Rancho Murieta Community Services District agrees to reimburse the Registrar of Voters for actual costs accrued, such costs to be calculated by the method set forth in the County's current Election Cost Allocation Procedures.

NOTICE OF DISTRICT ELECTION

RANCHO MURIETA COMMUNITY SERVICES DISTRICT

NOTICE IS HEREBY GIVEN that a General District Election will be held in this district on November 6, 1990. The offices for which candidates may declare their candidacy are:

3 positions as Director

QUALIFICATIONS: Each candidate must meet the following qualifications for office as specified in the principal act or code under which this district is organized:

Candidate shall be a registered voter residing within the boundaries of the District.

Code reference: 61200, Government Code

Official declarations of candidacy for eligible candidates desiring to file for any of the elective offices may be obtained from the office of the Registrar of Voters at 3700 Branch Center Road, Sacramento, California 95827, on and after July 16, 1990, and must be filed not later than 5:00 p.m. on August 10, 1990. However, if a declaration of candidacy for an incumbent is not filed by the latter date and hour, any person other than the incumbent shall have until 5:00 p.m. on August 15, 1990 to file a declaration of candidacy for such office.

Appointment to each elective office shall be made by the supervising authority as prescribed by Elections Code Section 23520 in the event there are not candidates or an insufficient number of candidates for such office and a petition for an election is not filed within the time prescribed by Elections Code Section 23520; that is, by 5:00 p.m. on August 15, 1990.
