

RESOLUTION 87-14

RANCHO MURIETA COMMUNITY SERVICES DISTRICT
RESCINDING RESOLUTION 87-9 DATED JUNE 10, 1987
REAFFIRMING RESOLUTION NO. 86-23 DATED DECEMBER 10, 1986

WHEREAS, Election Code Section 23302.1 provides that a district may, by resolution, require that its election be held on the same day as the Statewide General Election; and

WHEREAS, the Rancho Murieta Community Services District on December 10, 1986 adopted Resolution No. 86-23 requesting its general district election be consolidated commencing in 1988 with the Statewide General Election; and

WHEREAS, Chapter 188, Statutes of 1986, and Chapter 2, Statutes of 1987 (urgency legislation), pertaining to consolidations with the November 8, 1988 General Election contained drafting errors pertaining to the extension of existing terms; and the Sacramento County Board of Supervisors on May 26, 1987, declared their intention to deny requests of those districts that submitted timely resolutions, based on the current status of the law; and

WHEREAS, only because of the uncertainty of passage of corrective legislation, the Rancho Murieta Community Services District approved Resolution 87-9 calling for an election on November 3, 1987, with the intent for the election date to be changed to November 8, 1988, if said legislation was passed in a timely manner; and

WHEREAS, urgency legislation (Chapter 84, Statutes of 1987) was signed by the Governor on June 30, 1987, enabling the Board of Supervisors to approve on July 7, 1987 consolidation of the district's regularly scheduled election with the November 8, 1988 General Election;

NOW, THEREFORE, BE IT RESOLVED that the Rancho Murieta Community Services District hereby rescinds Resolution No. 87-9 calling for an election on November 3, 1987; and


BE IT FURTHER RESOLVED that Resolution No. 86-23 is hereby reaffirmed, and the Rancho Murieta Community Services District hereby declares that the regular election of the governing body of the district shall be held on the first Tuesday after the first Monday of November in even-numbered years, with said
