### **Rancho Murieta Security**

In 1998, Rancho Murieta’s Residents passed Measure J on a ballot in the primary election. After Proposition 218 was passed in California, CSD had no other way to fund its Security Department. This special tax established a baseline budget for 1999 of \$685,000 to fund both the gates and patrol. Twenty years later, Security costs Rancho Murieta nearly \$2 million per year. CSD reallocates money from property tax funds to make up the difference because our costs have outrun the taxes we are legally able to collect.

These property tax funds are money that could fund our reserves for water, sewer and drainage projects we must build or replace in future years. CSD has put a plan in place to ask the community if it would like to pay more to fund our security or change the way we currently operate. In February 2021, we will use an independent consultant to poll and survey our community to learn how the community would like CSD to proceed on this issue. We will be asking our residential, commercial, vacant land and country club stakeholders to participate and help us through this process. The survey will be conducted in a way that insures all areas of our community are represented. The process is being designed to include both a survey analysis and public outreach. There will be public stakeholder meetings to guarantee that everyone’s voice is heard on this important issue. The goal of CSD’s Board is to insure complete public visibility and that every effort is made to honor the majority opinion. It may be that the community is satisfied both by what we presently provide or with the tax we now pay.

The community may also prefer changes in the way we staff and respond. The ideas about security may differ by residential, commercial and the county club and even by individual residents. The final choice here will not be made by CSD. It will be guided by the voices and/or ballots of our ratepayers. The outcome will guide us as we attempt to stay within our budget and implement a security plan that will support and protect our community in future years. Feel free to comment on the process at the upcoming January CSD Board meeting. Please be ready to participate when we launch the actual public process in February.



### **KEEP GUTTERS, DRAIN INLETS & STORM DRAINS CLEAR**

## GENERAL MANAGER'S CORNER

### REINSTATEMENT OF LATE FEES AND INTEREST

At the beginning of the pandemic, the Governor issued an order which prohibited the District from shutting off water service for non-payment. Beginning with the March 25, 2020 billing cycle, the District discontinued water meter shutoffs and charging 10% late fees and 1% interest on delinquent accounts. As of December 10, 2020, the District has 48 delinquent accounts with a current outstanding balance of \$47,506. At the December 16, 2020 Board Meeting, the Directors voted to begin charging Late Fees on all accounts that are delinquent as of the January 25, 2021 billing cycle, and Interest on the balance of all past due accounts.

An account holder can enter into a pay agreement for their delinquent amount by calling the District office at 916-354-3700. By entering into an agreement, the account holder can pay their outstanding balance within 12 months, interest free. If the District and customer enters into a Payment Arrangement, the customer shall remain current on all new charges as they are billed in each subsequent billing period.

### Employee Spotlight – Chief Plant Operator, Travis Bohannon

### DEVELOPMENT UPDATE

MG—Lot 4, El Dorado Savings Bank - Is confirmed to be substantially complete.  
MG—Lot 5, Starbucks - This project has been signed off as substantially complete.  
Lot 10— PDF Office—Project Plan Review is done, waiting for fees to be paid to the District.  
MG – Lot 11 (Circle K Gas Station/carwash) - Coastland has provided comments.  
MG Legacy Villa’s & Suites project – The plans have been finalized by the project’s engineer and signed by Coastland Engineering. No word yet has been given as to a start date.  
Riverview— Coastland and Sacramento County are reviewing the plans. The Development is planning to grade the entire site. They have set up a construction trailer.  
Rancho Murieta Airport - Has proposed to add two storage Buildings and requested plan review.  
Retreats East and North - Has extended their tentative maps on file with the County.  
Rancho Murieta North—The project reports they are continuing work on a traffic study, greenhouse gas study, and schedule and notice of preparation.  
FAA Business Park—This project is nearly complete.

### NEW INTERIM SECURITY CHIEF—TINA TALAMANTES

The District is pleased to announce the hiring of Tina Talamantes, as the Interim Security Chief.

Tina Talamantes is a retired Lieutenant from the City of Stockton, Police Department. During her 28 year career, she served in a variety of roles within the Police Department, including Watch Commander of the Field Operations Division, Personnel and Training Manager, EEOC Officer, North Division Strategic Operations, and Crisis/Hostage Negotiations Team Manager. She was also the UAV (Drone) Team Manager, where the team provided geo mapping for the Butte County Paradise Fire, mutual aid to other agencies as needed, and assistance during critical incidents and protests. She implemented programs within the community to engage citizens and youth with police to establish and build trust and communication with law enforcement. She honorably retired from the Stockton Police Department July 2019.

Tina will work at the District until the return of Security Chief Werblun.



### FILLING THE RESERVOIRS

This is a brief explanation of the Cosumnes River diversion into our storage reservoirs (Calero, Chesbro, Clementia) for the Water Plants to process into drinking water for community use.

Depending on flow levels in the river, water may be pumped through the Granlees pump station to Calero or Chesbro, through a 33” pipeline, or to Clementia through a 21” pipeline. Typically we will be only filling Calero to allow sediment to settle out.

Diversion from the Cosumnes River may start November 1<sup>st</sup> and end by May 31<sup>st</sup>. Typically river flow from the first storms is allowed to pass by, flushing out the river system of sediment and possible contaminants washed in from roadways and agricultural areas, as our goal is to pump the cleanest water possible while being able to fill our reservoirs to maximum capacity each year.
