**RESOLUTION OF THE BOARD OF DIRECTORS OF
RANCHO MURIETA COMMUNITY SERVICES DISTRICT
DECLARING RESULTS OF THE ELECTION OF NOVEMBER 2, 2010**

WHEREAS, an election was held within the Rancho Murieta Community Services District pursuant to Resolution 2010-02 calling a General District Election to be held along with the General Election held on November 2, 2010; and

WHEREAS, it was submitted to elect three (3) Directors to the Board of Directors of Rancho Murieta Community Services District; and

WHEREAS, the number of nominees for the office of Director, Rancho Murieta Community Services District, did not exceed the offices to be filled, therefore no election for the Rancho Murieta Community Services District is required at the November 2, 2010 General Election;

WHEREAS, in accordance with Section §10515 of the Elections Code of the State of California, the Sacramento County Board of Supervisors appointed to such office the following persons who filed a Declaration of Candidacy and who shall take office and serve exactly as if elected at the General District Election.

WHEREAS, the Department of Voter Registration and Election, County of Sacramento has provided the Certificates of Election and Certificate of Facts.


