**WELCOME MIMI MORRIS—NEW GENERAL MANAGER**

We are pleased to welcome Mimi Morris as our new General Manager! She started with the District May 18, 2023. Mimi came out of retirement to lead the team at CSD, and has agreed to a three year contract with the District.

Mimi holds a master’s degree in accountancy, and has an undergraduate degree in Spanish literature.

Her past employment included overseeing all administrative aspects of the AmeriCorps program at the Governor’s office, where she resolved 7 audits over 9 years; streamlining the dispersal of \$122 million in bond funding for the California Cultural and Historical Endowment (CCHE); and reducing the back amounts owed to vendors at the Judicial Council of CA from \$100 million to \$1 million over 4 years.

Mimi has already been hard at work, acclimating herself to the District, overseeing the Budget process, and working on a response to the Grand Jury Report. Staff have welcomed her as their new leader, and look forward to all of the skills that she will use to reestablish the organizational culture, the processes and procedures, and the accounting system to make sure it is all functioning efficiently.

## FISCAL YEAR 2023-2024 BUDGET HEARING SCHEDULED

The 2023-2024 fiscal year for the District begins July 1, 2023. The budget, including Capital Projects and the proposed service charge increases is scheduled for the District's June 7, 2023 Regular meeting of the Board of Directors.

Directors and staff have been reviewing data and have capped the projected increase for residential customers to 13% outside of the gates, and 11% behind the gates. The rate could be reduced during these hearings, but not increased. Notices to customers regarding the rate increase were mailed on April 17, 2023 in compliance with Proposition 218. The proposed rate hike would increase the average residential bill \$21.54 outside of the gates and \$23.85 behind the gates per month.

You can protest the rate increase. Protests must be submitted in writing. Written letters of protest must be received at the District prior to the close of the June 7, 2023 public hearing. Email protest letters will not be accepted. Protests must contain your name and a description of the property in which you are the owner of record or tenant (customer of record). A street address and/or the assessor's parcel number are sufficient descriptions. Send your comments to Rancho Murieta Community Services District, C/O Director of Administration, P.O. ## CodeRed EMERGENCY NOTIFICATION SYSTEM

Rancho Murieta Community Services District has instituted the CodeRED Emergency Notification System. The CodeRED Emergency Notification System is a high-speed telephone communication service for emergency notifications. This system allows us to telephone all or targeted areas of Rancho Murieta Community Services District in case of an emergency situation that requires immediate action (such as a boil water notice, law enforcement emergency or evacuation notices). The system is capable of dialing 50,000 phone numbers per hour. It then delivers our recorded message to a live person or an answering machine, making three attempts to connect to any number.

### THIS SYSTEM WILL ONLY BE USED FOR DISTRICT EMERGENCY PURPOSES

Examples of times when the CodeRED system could be utilized: drinking water contamination, evacuation notice and route, missing children, fires or floods, law enforcement emergency, chemical spill or gas leak and other emergency incidents within the District where rapid and accurate notification is essential for life safety.

## What to Expect

Waterways will be extremely cold, fast-flowing and running higher than normal due to the melting of record snowpack during spring warm-up.

## Cold Water Safety

- This year's expected high runoff in rivers can be dangerous even with the use of life jackets.
- Do not enter cold, fast-running water. Never go near the water alone. Never enter the water to rescue a victim. Throw something that floats and call 9-1-1.
- Actively supervise children in and around open bodies of water.
